- Expenses included: \$60 BJ's annual membership renewal, \$134.00 to R. Zeller for March Madness fundraiser raffle prizes, \$250 to B. Green for winning bracket madness/\$150 to B. Kendrick for second place, \$371.16 to J. Gonzalez for track team timing system, \$98.81 to L. Dinunzio for facilities lunch/I Know A Guy

reimbursement and \$50 to Parent Booster for State of CT corporate annual report filing.
